**PLAINTIFF’S MOTION FOR AN AWARD OF ATTORNEYS’ FEES,
REIMBURSEMENT OF EXPENSES, AND SERVICE AWARD FOR THE
SETTLEMENT CLASS REPRESENTATIVE**

Pursuant to Rule 23(h) of the Federal Rules of Civil Procedure, Plaintiff Michael Evangelista (“Plaintiff” or “Settlement Class Representative”) respectfully moves for entry for an order:

1. Approving Class Counsel’s request for a combined attorneys’ fees and reimbursement of expenses award of one-fourth (25%) of the Settlement Fund, totaling \$2,487,500.00; and
2. Approving a Service Award of \$5,000.00 to the Settlement Class Representative in recognition of his participation in this case on behalf of the Settlement Class.

In support of his motion, Plaintiff relies on the accompanying memorandum of law and supporting Declaration of Gary F. Lynch. A proposed order will be submitted to the Court with Plaintiff's forthcoming motion for final approval of the National Student Clearinghouse settlement.
